CAN I GET UNEMPLOYMENT BENEFITS?

UNEMPLOYMENT INSURANCE IS FOR ELIGIBLE WORKERS WHO HAVE LOST THEIR JOB BY NO FAULT OF THEIR OWN.

FOR OHIO, if you are out of work due to COVID-19 and need to file an unemployment application, use the MASS LAYOFF #2000180 when you apply

FEDERAL STIMULUS FUNDS?

- For most taxpayers, payments are automatic, and no further action is needed. This includes taxpayers who filed tax returns in 2018 and 2019 and most seniors and retirees.

- The IRS will be developing a "GET MY PAYMENT" APP to check your payment status, payment type and direct deposit bank information. APP reported to be available mid-April 2020.

CAN I STILL VOTE?

Voting in the Ohio Primary Election (OHIO PRIMARY HAS BEEN EXTENDED BY MAIL ELECTION TO APRIL 28, 2020) is important, especially because it confirms your registration is secure to vote in the November General Election. If you didn't get a chance to vote early, here is what you can do:

- Check with your counties' Board of Elections TO REQUEST AN ABSENTEE APPLICATION. This application is required to receive a ballot for this year's Primary Election. Complete and submit application BEFORE NOON ON APRIL 25, 2020.
- You can also pick up an ABSENTEE APPLICATION at various Kroger locations, calling 513-632-7000 or <u>https://votehamiltoncountyohio.gov/wp-content/uploads/2020/04/20MailAppMarPri4-13-2020.pdf</u>
- After submitting the application, a ballot will be mailed to you. Complete your ballot and either drop-off at your Board of Elections (due by 7:30pm on April 28, 2020) or returning via mail (postmarked by April 27, 2020).

THE IMPORTANCE OF THE CENSUS DATA

- Required by law to complete If you have not responded to census by the end of May, official census takers will start home interviews (based on current 2020 timelines)
- Determines congressional representation

- School lunches
- Plans for highways
- Support for firefighters
- Support for families in need
- Results used to determine Federal Funding affecting our community every day for the next 10 years
